Project Aims



Funded by Peace IV: Objective 1: Shared Education (€4.2m across 4 year period)

It Aims To:

- 1. Improve Educational Outcomes
- 2. Promote good relations

Shared Education is the provision of direct, sustained, curriculum based contact between pupils and teachers from all backgrounds through collaboration between schools from different sectors in order to promote good relations and enhance children's skills and attitudes to contribute to a cohesive society.

Project Targets



- 99 individual pre-school settings (64 in Year 1)
- 157 individual teachers / leaders trained to facilitate shared education
- 9,914 children (cumulative over the 4 years)

Eligible Pre-school Settings



- Statutory pre-school nurseries and nursery units in NI
- Voluntary and Private pre-school settings within PSEP in NI
- Community and Private pre-school settings funded through ECCE in SBCs

What does *Sharing from the Start* involve?



- Applicants from NI are invited to form cross-community partnerships (partnering with a setting with children of a predominantly different religion).
- In the ROI, where this is not possible, applicants will be encouraged to partner with settings with children from a different ethnic or socioeconomic backgrounds.
- Plan and deliver joint curricular sessions together 30 hours per school year (e.g. 10 x 3 hour sessions).
- These sessions will proactively help settings achieve a number of the quality outcomes in both ETI / DES inspections in NI and ROI.

Benefits to be gained from the Project



- Training, mentoring support and professional development for staff
- Supporting the achievement of quality standards
- Support for inclusion, equality and diversity
- Additional curriculum resources and professional expertise
- Peer support
- Opportunities for learning, networking and sharing good practice
- Workshops for parents, management committee members / board of governors
- Opportunities for cross-border collaboration (where applicable)

Package of Supports



Indicative figures:

- £80.50 / €95 per eligible child* who completes 30 hrs Shared Education in Year 1 (costs associated with shared sessions e.g. transport, specialist tutors)
- £302 / €356 per setting for resources that support good relations, inclusion and diversity
- 3 days substitute cover** for leaders / teachers to attend training;
- 1 day substitute cover** per setting per annum for planning with partner/s

Timeline for Year 1 (2017/18)



- Closing date for applications (31st October 2017)
- 3 day training (TBC Jan June 2018)
- Deliver first joint session with children (December 2017)
- Deliver remainder of shared education sessions (January June 2018)
- Workshops for parents, management committee / board of governors TBC with each partnership (January – June 2018)
- Review Year 1 and Plan for Year 2 (April June 2018)

Assessment of Applications



Criteria:

- 1. Eligible settings
- 2. Little or No previous experience of Shared Education
- **3. Cross-community partnerships** Applicants from NI are invited to form cross-community partnerships (partnering with a setting with children of a predominantly different religion).
- Applicants from ROI/SBCs are encouraged to partner with settings with children from a different ethnic or socio-economic backgrounds

Ranking Criteria



- Social Disadvantage (NI)
- Newcomer children
- Partnering with **nearest** eligible setting
- Cross-border partnerships (i.e. involving partners from both NI and SBCs)
